Performance Highlights

Cybersecurity and Information Assurance

Federal Aviation Administration (FAA)

Concordant's engineers secure the FAA Emergency Operations Network ensuring uninterrupted operation of the National Airspace System, allowing positive control of 45,000 flights and 2.9 million passengers daily.
